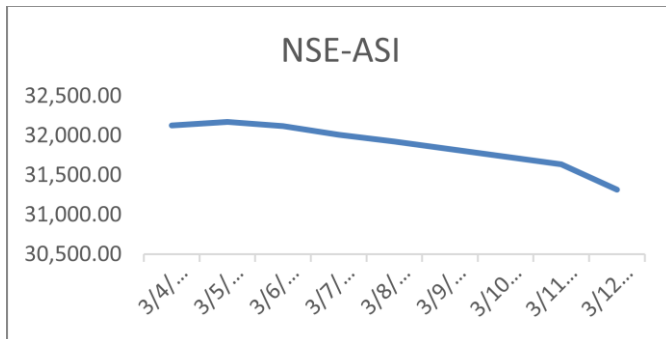


Market Summary
