

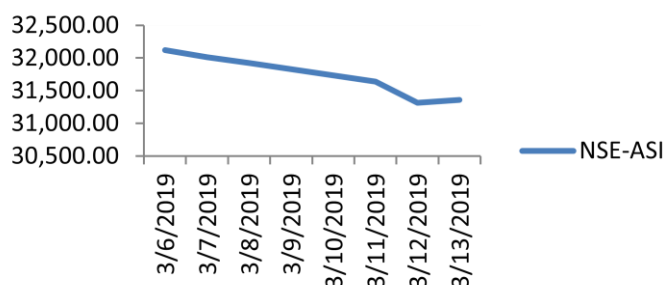
Market Summary
