

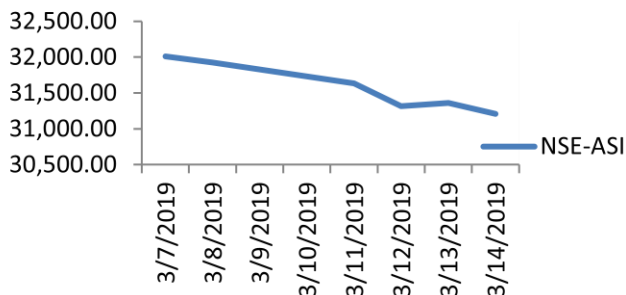
## Market Summary
