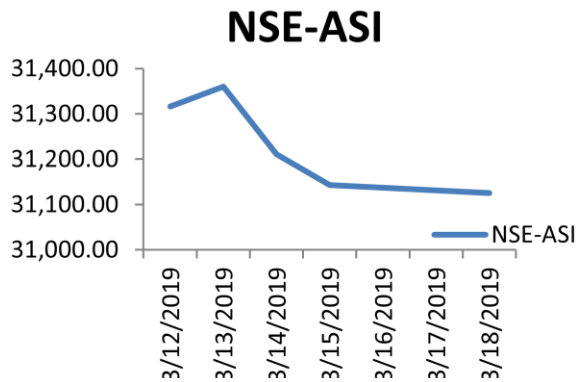


Market Summary
