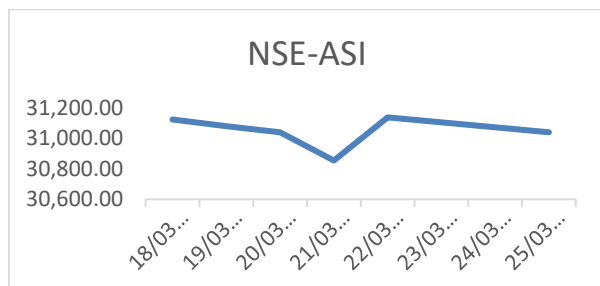


Market Summary
